

Joint Controller Statement

1. Introduction

Billie Jean King Cup Limited is a company registered in England and Wales under company number 14940977 (“**BJKCL**”).

ITF Licensing (UK) Limited (trading as the International Tennis Federation) is company registered in England and Wales under company number 02584446 (“**ITF**”).

BJKCL and ITF are referred collectively as “we”, “us” and “our” in this Joint Controller Statement. We are both companies within the ITF group, and we each have responsibilities in relation to the running of the Billie Jean King Cup competition. We work closely across a range of areas to ensure the competition is run efficiently and effectively.

2. Joint Controller Relationship

In some cases, when we are each performing our responsibilities in running the Billie Jean King Cup, we share your personal information and make joint decisions about why and how we process your personal data. This means that we are considered “joint controllers” under data protection laws.

This Joint Controller Statement sets out the arrangements that have been agreed between us as joint controllers of your personal information, including who will be responsible for providing you with information about how and why we use your information and who will be responsible for dealing with a request from you.

3. Joint Processing
