

ITF Wheelchair Tennis Player Grant Application Terms and Conditions **(the “Grant Application Terms and Conditions”)**

The Terms and Conditions apply when submitting an application to the ITF for the award of an ITF Wheelchair Tennis Player Grant (the “**Grant**”) (the “**Application**”):

1. Use of Grant

If awarded:

- The Grant will be used solely towards achieving the Applicant Player’s wheelchair tennis goals and objectives as described in the Application, and only by the Applicant Player, and under no circumstances shall it be used for any other purpose.
- The Applicant Player shall use their best endeavours to meet their objectives and goals as outlined in the Application.
- The Applicant Player’s use of the Grant monies will comply with any specifications agreed with the ITF.

3. Gifts

- No gift may be made, and no advantage or benefit (direct or indirect) promised or provided to any ITF Board member, relevant Committee or Commission member, or ITF staff member that is intended or may reasonably be construed as being intended to influence the recipient to make decisions other than in the best interests of the ITF.

4. General

In submitting an Application, the Applicant Player and Applicant National Association agrees that:

- The ITF shall be entitled to terminate the application process, withdraw from any negotiations, or extend the application process in order to seek additional Applications, at any time in its sole discretion.
- The ITF shall judge all Applications applying such criteria as it sees fit and shall have sole discretion as to any decision or decisions which it reaches. The ITF shall not be obliged to make any award in respect of the Grant should it choose not to do so, nor to enter into correspondence with applicants.
- The Applicant Player and the Applicant National Association, including including its employees, agents, and other(s) acting on its behalf must treat all Applications, the application process, and all related correspondence as confidential.
- The material shared as part of the Application and the application process is not intended to constitute formal agreement between the ITF and the Applicant Player and/or the Applicant National Association. A successful Applicant Player and/or Applicant National Association will be required to agree to contractual terms which are acceptable to the ITF, as well as themselves.



- Without the prior written approval of the ITF, the Applicant Player and Applicant National Association, including its employees, agents, and other(s) acting on its behalf, shall not make public statements in relation to any Application, the application process, or any termination or conclusion of or exclusion from the process.
- The ITF bear no liability in respect of any loss or damage (whether direct or indirect) suffered by the Applicant Player or the Applicant National Association, including its employees, agents, and other(s) acting on its behalf, in relation to the Application nor the application process.
- The Application and the application process, including the award of a successful Application, shall be governed by and subject to the laws of England and Wales.

4. Reporting

The Applicant Player understands and agrees that if the Application is successful:

- Upon the approval of a Grant, the ITF will provide the Applicant Player with a questionnaire which the Applicant Player agrees to complete and return to the ITF within a reasonable timeframe as specified by the ITF.
- During the December of the calendar year in which a Grant is approved, the ITF will send to the Applicant Player a further questionnaire, which the Applicant Player agrees to complete and return to the ITF within a reasonable timeframe as specified by the ITF.

5. Data Protection
