

**ITF World Tennis Masters Tour**  
**2025 Summary of Regulation Changes**

Please find below a summary of the key regulation changes being implemented on the ITF World Tennis Masters Tour in 2025. Please note that this document highlights a summary of the main rule changes for 2025 – please refer to the full ITF World Tennis Masters Tour Regulations 2025 [HERE](#).

**Masters Tour Regulations**

**4. Players Eligible - Good Standing rule updated (page 2):**

Only players who are under the jurisdiction of a national tennis association affiliated to the ITF may compete in any tournament to which these Regulations apply. Players wishing to represent (either as a player or captain) a nation in the World Team Championships or other international team competitions on the WTMT must be in good standing with their national association as defined in Appendix V of the Masters Regulations.

**5. International Player Identification Number (IPIN) – increase (Page 3):**

Each tournament entry (whether for Singles or Doubles or both) must be accompanied by a USD \$10.00 IPIN fee (Tournament IPIN Fee). The Tournament IPIN Fee will be fully refunded to a player that withdraws from the Tournament prior to the Withdrawal Deadline.

Players will be required to pay the \$10.00 USD IPIN fee for their first six (6) tournaments in a calendar year. The fee will be waived for any player competing in their 7<sup>th</sup> tournament onwards in the calendar year from 1 January 2025 to 31 December 2025. Therefore, the maximum IPIN fee for player shall be \$60 USD (compared to \$56 in recent years up to 2024).

**14. Sanction Fee increase (Page 10):**

\*New tournaments at MT100 will pay a discounted sanction fee of \$100 USD in their first year only.

**19. Method of Ranking (Page 12)**

**Doubles/Mixed Doubles**

A player will only appear in one doubles and/or one mixed doubles age group ranking. All ranking points earned will be awarded to a player's own age group (previously a player may hold multiple doubles rankings)

**World Championships - Singles**

A player may compete in more than one (1) World Individual Championships singles event throughout the calendar year. Singles ranking points earned will remain in the age group event in which the player competed and will not be awarded in their own age group if they choose to play in a younger age category.

### World Championships - Doubles

A player may compete in more than one (1) World Individual Championships doubles event throughout the calendar year. Ranking points from the event in which the player reached the furthest round will be awarded to their actual age group and therefore will appear in one doubles and/or mixed doubles age group ranking.

### 20. Allocation of Points (Page 14):

World Individual Ranking points for singles, doubles and mixed doubles will be awarded as set out in the points table in Section I, Regulation 21 below. For ranking purposes, the definition of a tournament is determined by the ITF. A Tournament can be played across multiple dates and locations with different entry deadlines. This will be indicated in the Masters Calendar and factsheet.

- i) Should a player compete in one (1) singles event in a tournament that takes place over multiple dates and locations, ranking points won will be awarded to the age group in which the player participated.
- ii) Should a player compete in two (2) singles events in a tournament that takes place over multiple dates and locations, ranking points won in each event will be awarded in the age group in which the player participated.

### 21. ITF Points Tables for Singles, Doubles and Mixed Doubles Rankings (Page 15):

Ranking points available for Bonus Draws increased:

\*Players in bonus draw events cannot earn a greater value of ranking points than players winning matches in the main draw. For main draws consisting of 33-64 players, the winner of the Bonus Draw will receive the

Bonus Draw Runner-Up ranking points for the grade, with points cascading through the rounds. For main draws consisting of 65 or more players, the winner of the Bonus Draw will receive the Bonus Draw Semi-Final ranking points for the grade, with points cascading through the rounds.

### 21. ITF Points Tables for World Team Championships (Page 17/18):

Ranking points awarded to Individual players

#### **Round Robin Stage (Days 1-3)**

All match wins at the Round Robin (days 1-3) stage will earn players the same value of ranking points.

Round of Match	#1 Singles and #1 Doubles	#2 Singles
Round Robin Stage (Days 1-3 of Team Event) Includes any Round-Robin draw in second stage of competition (Days 4-6) for 4th position onwards.	125 points per win	100 points per win

### Second Stage Play-Off Draws (Day 4-6)

Additional points may be earned from players competing in the remaining days of competition which recognise the increased strength of opponent.

Round of Match	#1 Singles and #1 Doubles	#2 Singles
Non-Main Draw Playoff Matches	125 points per win	100 points per win
Main Draw Quarter Finals and 5th-8th place playoffs	250 points per win	200 points per win
Main Draw Semi Finals and 3rd/4th place playoff and Second Stage Round-Robin groups for 1st -3rd place	350 points per win	300 points per win
Main Draw Final (1st/2nd elimination match only)	500 points per win	450 points per win

The maximum ranking points that can be earned by a player in the 2025 ITF Masters World Team Championships is 1,225 points for the event.

### 21B. Regional Team Championships

Ranking points awarded to WTMT Regional team Championships

<b>Round Robin Stage &amp; Any Additional Team Matches for 5<sup>th</sup> position onwards</b>
60 points per player for a win in singles and doubles
<b>Main Draw Quarter Finals, Semi-Finals, 3<sup>rd</sup>/4<sup>th</sup> Playoff and Main Draw Final only</b>
100 points per player for a win

Players must compete in no more than 7 singles and/or 7 doubles matches during the overall event. Only the best four (4) results of an individual player during the event – based on ranking points earned - will be included in the final count (Max 360)

Singles and Doubles points will be applied separately, as is the case in ITF Masters Tour events

### 27. Criteria for Acceptance (Page 22)

World Tennis Number – Change to rating confidence level.

\*Players must achieve a rating confidence level of 50 or better at the time of entry deadline for the ITF World Tennis Number to be applied as part of the singles acceptance process. Players can view their rating confidence level at [ipin.itftennis.com](http://ipin.itftennis.com)

## SECTION III

### CODE OF CONDUCT

#### ITF WORLD TENNIS MASTERS TOUR, ITF WORLD TEAM AND INDIVIDUAL CHAMPIONSHIPS (WTMT) (Page 89):

#### K. Coaching and Coaches

For the avoidance of doubt, off court coaching (as defined in the Rules of Tennis) is not permitted on the ITF World Tennis Masters Tour.

## APPENDIX I

### National Closed Championships (Page 107):

#### **National Closed MT100, MT200 and MT400 Tournaments**

Each tournament entry (whether for Singles or Doubles or both) must be accompanied by a USD \$4.00 IPIN fee ("Tournament IPIN Fee"). The Tournament IPIN Fee will only be fully refunded to a player that withdraws from the Tournament prior to the Withdrawal Deadline.

#### **National Closed MT700 Tournaments**

Each tournament entry (whether for Singles or Doubles or both) must be accompanied by a USD \$10.00 IPIN fee ("Tournament IPIN Fee"). The Tournament IPIN Fee will only be fully refunded to a player that withdraws from the Tournament prior to the Withdrawal Deadline.

## APPENDIX II

### **REGIONAL TEAM & INDIVIDUAL CHAMPIONSHIPS (Page 109):**

Extended rules to cover Regional Team Championships

1. Each Regional Association can host one (1) Regional Team Championships and one (1) Regional Individual Championships per year, with applications needing approval from both the Regional and National Association.
3. Eligibility for participation in the Regional Team Championships is determined by the entry criteria established by the Regional Association in collaboration with the ITF.
8. Tournament Organisers hosting a Regional Individual Championships must use the official ITF tournament software (TP) for collecting and submitting results to the ITF. Tournament organisers must use the online entry facility provided by the ITF.
9. Unless otherwise approved, Tournament Organisers hosting a Regional Team Championships must use the official ITF Teams tournament software (TEP) for collecting and submitting results to the ITF. Tournament organisers will collect entries and forward to the ITF at entry deadline.
10. In submitting an application, a tournament automatically undertakes to abide by and fulfil all its obligations set out in the Regulations including Code of Conduct.

**APPENDIX VI**  
**DATA RIGHTS (Page 124):**

**1. Definitions**

The following terms shall have the following ascribed meanings:

- APPROVED PAT** means any system of Player analysis technology that is approved by ITF (which may include a Eligible ELC System).
- ELC DATA** means any data collected, generated or derived from a Eligible ELC System.
- ELIGIBLE ELC SYSTEM** means an electronic line calling system that: (i) is an Approved PAT; (ii) is classified by the ITF or Joint ELC Committee (as applicable to the level of classification); and (iii) has been approved by ITF for use at the relevant Tournament or event.

**4. Use of Approved PAT**

National Associations shall be entitled to use Approved PAT at Tournaments, and Players and coaches shall be entitled to use their own Approved PAT in matches which they participate in, in each case provided that: (i) they notify and obtain prior written approval of the ITF in advance of each Tournament where they are seeking to use an Approved PAT; and (ii) their use of the Approved PAT and PAT Data generated therefrom complies at all times with the terms of these Regulations (including Appendix VI).

Players and coaches are not allowed to operate their own Eligible ELC Systems, but they shall be entitled to use Eligible ELC Systems operated by the ITF or any National Association in accordance with these Regulations.
